Travel Subsidies

Thanks for project funding for this event – this year we are able to offer very generous travel subsidies for those coming from outside the Greater Brisbane area.

Travel subsidies for this event are available per person, not per centre.

Option 1: Flights and Accommodation

Community Legal Centres Queensland will pay up to \$1000 per person towards the costs of flights and accommodation.

Option 2: Driving and Accommodation

Community Legal Centres Queensland will pay up to \$750 per person towards the costs of accommodation, driving and parking.

To apply for the funding you will need to submit a travel claim by providing:

- 1: Tax invoices for the booked travel/accommodation
- 2: Create a tax invoice from your community legal centre addressed to Community Legal Centres Queensland (CLCQ) for the amount you are applying for (inclusive of GST).

Please reference the invoice as "Wunya Travel Subsidy".

Please note – you can only claim up to the travel allowances as listed above or the amount you have spent. For example, Under Option 1, if your expenses total \$1094, you can apply for \$1000 but if your expenses total \$876, you can only apply for \$876.
